Abstract: With the closing of each business day, attorneys throughout the world are increasingly engaging in cross border transactions on behalf of established and early stage clients. With the advent of both the global and digital economies, once rigid national borders are becoming more porous with technology flowing quickly around the globe. The ability of technology to transcend national borders implicates intellectual property laws and courts of several jurisdictions—many of which may conflict. This panel will discuss the top emerging intellectual property risks and issues that are arising within international cross border transactions, including: data protection, the development of "right to be forgotten" policies, the governmental responses to so-called "patent troll" litigation, and the impact that 3D printing has on intellectual property enforcement. The panel will provide an overview of each of these issues and assess their impact on cross border transactions from both a national and international perspective.
