ALERT - California's Prohibition of Out-of-State Forum Selection Clauses in Franchise Agreements is Alive and Well

A California District Court ruling in Frango Grille USA, Inc. v. Pepe's Franchising Ltd. provides a certain amount of comfort to California franchisees that any disputes with foreign franchisors will be venued in California. By doing so, the Frango Court managed to work around a recent United States Supreme Court ruling which held that contractual forum selection clauses would be enforced under Federal law in all but the most extraordinary circumstances. The Frango decision is a victory for California franchisees, and should serve as a warning to foreign franchisors that they will have to litigate disputes with California franchisees in California.

National Labor Relations Board Mandates That Employers Allow Employees Use of Work Email For Union Organizing and Related Activities

In a much anticipated decision, the National Labor Relations Board ruled last Thursday that employers must permit employees the right to use work email systems for union organizing and other concerted activities relating to terms and conditions of employment. As is typical, the Board was divided and issued the ruling on a 3 to 2 vote. This decision overrules prior NLRB precedent holding that employers could prohibit employees this type of access to their work email systems. In *Purple Communications, Inc.*, 361 NLRB No. 126 (Dec. 11, 2014), the NLRB held that email has become a critical means of communication and that therefore, the Board's previous position on this issue undervalued employees' rights to communicate in the workplace about their terms and conditions of employment and gave too much weight to employers' property rights.

An investment in another person's business that is not publicized, that does not include any executive authority and does not involve personal liability risk is referred to as a typical silent partner investment. From a tax law perspective, the typical silent partner generates income from capital investments. If, on the other hand, there are deviations to these principles, and if the silent partner bears a certain amount of risk as a co-entrepreneur, he is referred to as an atypical silent partner, who earns commercial income.
