COLLECTIBILITY IN LEGAL**

MALPRACTICE ACTIONS

When clients are harmed by the malpractice of a lawyer, they often times face a second, potentially more complicated, lawsuit. The plaintiff must prove both the underlying case and negligence against the original lawyer who committed malpractice in order to win the malpractice action.

While Colorado courts have long recognized the solvency or insolvency of the underlying defendant must be proven, only recently have the courts answered the question of whether that responsibility lies with the plaintiff or defendant lawyer.

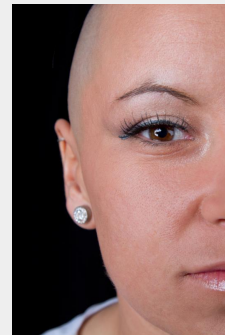
